DEMONSTRATING VALUE

The first goal in the AAACN strategic plan is to empower members to demonstrate their important role in healthcare by building the evidence on the value of ambulatory care nursing. The following are areas we have advanced in 2023 towards achieving the goal.

Building the infrastructure for AAACN to design, conduct, and disseminate research.

Scheduled to launch in 2025, the brand new Journal of Ambulatory Care Nursing will be peer-reviewed journal dedicated to advancing evidence-based ambulatory care nursing practice, clinical research, and professional development. Led editor Susan Fowler PhD, RN, CRRN, NE-BC, the first editorial Board **FCNS** assembled featuring a diverse set of ambulatory care experts including Beth Ann Swan, PhD, CRNP, FAAN, Nancy May, DNP, AMB-BC, NEA-BC, FAAN, Kathy Mertens, DNP, MN, MPH, RN, Leilani A.C. LG Siaki, PhD, FNP-BC, FAANP, Brandy Williamson, MSN, RN, CPN.



The Journal also conducted the first call for manuscript reviewers and over 30 volunteers. Finally, the author and submission guidelines were published leading to the open call for manuscript submissions. Submit today to be considered for one of the first issues of the journal.

DEMONSTRATING VALUE

Building the infrastructure for AAACN to design, conduct, and disseminate research continued.

The Research Committee led by AAACN's Nurse Scientist, Margo Halm, PhD, RN, NEA-BC has continued to build the structure to help AAACN build the evidence on the value of ambulatory care nursing. The committee conducted a review of the scoping current state ambulatory nursing knowledge. The search yielded over 36,000 studies! The committee is also working on presenting at the Annual Conference where attendees will gain a deeper understanding of evidence-based practice from project identification through dissemination.

Continue to support, develop strategies, and disseminate resources that articulate the value of the professional nurse.


The **NSI Task Force** lead by co-chairs: Rebecca Dellefave, BSN, RN, MS; Rachel Start, MSN, RN, NEA-BC, FAAN; and Ann Marie Matlock, RN, DNP, NE-BC are in the process of revising the Nurse-Sensitive Indicator Industry Report. The updated, expanded edition is expected to be available in the summer of 2024.

The Role of the RN in Ambulatory Care Nursing Paper Task Force has revised the AAACN Position Statement which reflects the current state of ambulatory care and the crucial role of the RN as a care provider, care coordinator, and care partner. It also highlights potential role changes and adaptations for the future. Chair Aleesa Mobley, PhD, RN, ANP-BC, CPHQ and Co-Chair Jean Bernhardt, PhD, MSN, NEA-BC, CNP will present their findings during the Annual Conference.

ADVANCING COMPETENCY

Provide resources to AAACN members that support the evolving role of ambulatory care nurse.

The revised **Scope** and **Standards** of **Practice** for **Professional Ambulatory Care Nursing** was published in 2023. The 10th edition contains significant revisions from previous versions. In addition to the revised scope of practice, the publication contains 17 standards. The first six standards address the phases of the nursing process; the last 11 standards address professional performance. These changes



offer clarification and specificity for the distinct domains of clinical and administrative nursing practice in ambulatory care settings. Purchase today from the AAACN bookstore.

The Workplace Safety Task Force led by Chair Dawn Fletcher, DNP, NEA-BC, RN and Co-Chair Beth Sparks, RN, MSN, CNML published a new AAACN Position Statement on Workplace Violence, Incivility, and Bullying in Ambulatory Care. The statement describes the vast impact of workplace violence on ambulatory care nurses and the critical role nurses must play in advocating for its prevention and lays out the basic tools and actions needed in preventing an event, during and after an event, and in influencing a culture of safety within an organization.

AAACN's **DEI Committee** chaired by Amy Cadoret, MHA, MSN, NEA-BC, AMB-BC launched a new DEI webinar series. The free quarterly calls featured topics covering LGBTQ+ Patient Identities, Cultural Humility, Sexual and Gender Identity, and Leadership.

ADVANCING COMPETENCY

Provide resources to AAACN members that support the evolving role of ambulatory care nurse continued.

The **Publications Committee** guided by Chair Cara Spencer, PhD, RN, FNP-BC and Co-Chair Caroline Coburn, DNP, MS, ANP-BC are responsible for overseeing the AAACN publication review timeline, making recommendations for authors, and writing groups, monitoring progress of production, and proposing new publications. They have been working on identifying new editors for the *Core Curriculum for Ambulatory Care Nursing* and exploring new ways to modernize our resources.

The 2023 **Virtual Leadership Symposium**, Shaping Care Where Life Happens. This Symposium was held as a thank you to our volunteers and to build our leaders. The goal of this year's symposium was to provide them with leadership development opportunities, professionally and within AAACN. This year's session included a presentation, The Power of Nursing from Rebecca Love, RN, MSN, FIEL, an update from our new Nurse Scientist, Margo Halm, an update of our strategic plan, rebranding and leadership pathway by AAACN's CEO Pete Pomilio and a discussion led by our President-elect Rachel Start with our 2022 Emerging Fellow Board members, Jessica Polk and Brandy Williamson on their experiences in their first year of this new position.

AAACN's **Special Interest Groups (SIGs)** continues to be one of the most valued member benefits that allow members to connect across eight specific topic areas: Care Coordination and Transition Management (CCTM), Leadership, Nurse-Sensitive Indicator (NSI), Pediatrics, Staff Patient Education, Telehealth Nursing Practice, Tri-Service Military, and Veterans Affairs. In 2023, networking calls were introduced to allow more time to exchange ideas and connect with other members.

SHAPING CARE

To leverage the expertise of AAACN to influence healthcare.

The **Advocacy Committee** chaired by Tracy Gosselin, PhD, RN, AOCN, NEA-BC, FAAN has been very active as they work to influence legislation. Through AAACN's involvement with the Nursing Community Coalition, a forum for professional nursing organizations to collaborate on a wide spectrum of healthcare and nursing issues, including practice, education, and research, the committee reviews and determines if AAACN should support, or not support legislation that will affect AAACN members, and the practice of ambulatory care nursing. The committee also developed a response to the proposed CMS physician fee schedule. AAACN has engaged an outside consultant to develop an overall plan and strategy that will help AAACN influence healthcare. The committee will share the initial plan during the Annual Conference during the Town Hall.

The strength of AAACN lies in the combined knowledge and skills of our members. We have been actively exploring methods to recognize **subject matter experts** within our membership, aiming to deploy them in situations where AAACN can demonstrate its expertise. A request for volunteers was initiated, with more than 150 members stepping forward to contribute, thus assisting in the development of our initial database.

AAACN continues to foster **strategic partnerships** with several key stakeholders to discuss ways to improve healthcare and ensure ambulatory care is represented.



The 2023 AAACN Annual Conference was an event enlivened with a passionate call for the ambulatory care nursing community to lead boldly as healthcare advocates of change, fueled by a collective devotion to share clinical and workplace expertise in support of creating physically and psychologically safe healthcare settings of equity and inclusion for all. In total, the conference program was a courageous call for ambulatory care nurses to be "the change."

The Annual Conference embodied the leadership spirit of AAACN, bringing 1,026 registrants and more than 20 exhibitors together for a powerful hybrid program championed by insights from more than 75 speakers over a 5-day event held April 11-15 at the Omni Orlando Resort at Champions Gate in Orlando, FL.

In the conference's opening remarks, AAACN President Deena Gilland, challenged attendees to think about AAACN's ability to reshape the ambulatory care nursing profession for a world increasingly committed to propelling healthcare equity for all.


The opening keynote presentation, Advocacy: Amplifying Voices to Improve Healthcare, presented by Billy Rosa carried Gilland's opening remarks to take attendees even deeper into the mechanism that is healthcare advocacy – inspiring attendees to amplify their voices and, in doing so, the voices of patients, families, colleagues, institutions, and multidisciplinary stakeholders to make measurable and tangible improvements in health outcomes.

With advocacy leading many discussions, a mindful and informative Town Hall focusing on workplace safety in the ambulatory care nursing environment presented an opportunity for attendees to share individual practice experiences. Facilitators and Co-Chairs of the AAACN Workplace Safety Task Force Dawn Fletcher, and Elizabeth Sparks, hosted a panel supported discussion of workplace violence prevention efforts, with a focus on development of action planning and strategic response.






Position

Highest Level of Education




FINANCIAL UPDATE

Gross Income




Gross Expenses
