

## AAACN Telehealth Nursing Practice Core Course (TNPCC) AT YOUR LOCATION

AAACN's Telehealth Nursing Practice Core Course (TNPCC) can be given at your location. AAACN will work closely with your practice facility to customize the logistics of the course as much as possible. We would welcome a phone conference with you to answer any further questions you may have and determine a plan that would work best for your facility.

The course is a one-day event offering **8.0 contact hours.**\* This is a basic course that reflects current practice and is useful in orienting nurses new to telehealth practice, enhancing knowledge of telehealth practice, and provides staff education and training in telehealth nursing to nurses practicing in any setting.

Course content is based on the *Telehealth Nursing Practice Essentials* text book. Topics include an Overview of Telehealth Nursing Practice; Focus and Roles; Customer Service, Communication Principles and Techniques; Legal Aspects of Telehealth Nursing; Decision Support Tools; Documentation of Telehealth Encounters; *Clinical Knowledge including:* Assessment, Special Situations, At Risk Populations, Pediatric Populations, Geriatric Populations; Care of the Nurse; and Technology.

**Number of participants:** We recommend 60 or less participants. The course is presented by a minimum of two faculty for groups less than 60.

The AAACN fee to present the course is \$4,000 for the first 60 participants. The fee for additional participants is \$50 per person. The fee includes faculty honoraria, copyrighted course content, provision of contact hours, continuing education certificates, a camera-ready course handout to be duplicated by the host facility, and staff coordination.

**SITE LICENSE OPTION:** For a flat fee, based on the number of users, a **site license** is available. Contract <u>celess.tyrell@aij.com</u> for more information. This would give your facility the capability to use the course to educate any nurse within your facility, including any new telehealth nurses you hire in the future.
